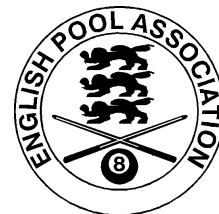

## INSTRUCTIONS FOR COMPLETION OF EPA ID CARD REGISTRATION FORM

ALL APPLICATIONS:	Must be completed correctly, clearly and must be accompanied by the relevant fees. If you are transferring from another County Association please speak to your new County Secretary reference filling in a transfer form. Section 6 of the ID Registration of ID members.
NEW APPLICATIONS:	Must be accompanied by two (2) passport sized photos. One photo must be attached to the form In the space provided & the other attached using a paper clip.
JUNIOR APPLICATIONS:	As all others + <b>MUST BE COUNTERSIGNED BY</b> Parent/ Legal Guardian. Regional Collator to add a 'J' behind the players I.D. Number
RENEWALS:	As per all Applications.
CHANGE OF DETAILS:	See following categories.
JUNIOR TO ADULT:	As per new application + old card must be returned. Same number to be used without the 'J'
NAME CHANGE ETC:	As per new application + old card must be returned.

## REPLACEMENT CARDS

LOSS OF PHOTO CARD:	As per all applications + new application.
LOSS OF YEAR CARD:	As per all applications + renewal.

## RETURNING FORMS

WITHIN COUNTY STRUCTURE:	Return to person named on form/ County Registration Official.
IF COUNTY REGISTRATION OFFICAL:	Return to your Region Registration Official.

## ALL CARDS

ALL CARDS:	MUST be laminated
PHOTO ID CARDS:	Front - MUST have players Photo plus the Regional Registration Officials signature & date of issue. Rear- MUST have a E.P.A Players I.D Registration membership number- players name.
YEAR CARDS:	Front – Must be year card colour – Signed and dated by the Regional Registration Officials. Rear - MUST have players Name & EPA ID Registration membership Number - Inter-League team the player plays for in that season.

NB. Any incomplete, incorrect and/ defaced forms received by the Regional Registration Official will be returned to the County Official concerned without the players on those forms being registered.
